The value of clinical audit

- Increased need to translate data into actionable improvement
 - Darzi report, autumn 2024; 2025-26 NHS Priorities
- Increased attention in NHS England concerning implementation of National Recommendations eg EQG-NCA, themed meetings
- NHS Plan:
 - From analogue to digital
 - From hospital to community
 - Improved prevention
- National Clinical Audit Benchmarking (NCAB) / Model Health
- Outliers – guidance – non-participation
- National Registries and Clinical Audit plan

Quality improvement can - and must - follow on from clinical audit...

Key questions to ask...

- Do we know how good we are?
- Do we know where we stand relative to the best?
- Do we know/understand where variation exists in our organisation?
- In our efforts to improve, what's working?
- Why are we measuring all this, and what difference is this actually making to the quality of services?

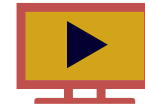
